1	Candidate making of Marks, signs Writing of Roll Numbers, Name or any other form of disclosing identity with a clear intent of getting illegal benefit.	Cancellation of performance of candidate in the subject in present examination. ( <b>1+0</b> )
2	Making an appeal to the Examiner revealing both One`s Name and Address	Cancellation of performance of candidate in the subject in present examination. ( <b>1+0</b> )
3	Writing provocations or abusive and threatening language in the answer books	Cancellation of performance of candidate in the subject in present examination. ( <b>1+0</b> )
4	Candidate or his associates influencing the Examiner/Moderator/Authority connected with the Examination	Cancellation of performance of candidate in the subject in present examination and debarring for two subsequent examinations. ( <b>1+2</b> )
5	Communicating or talking with another candidate	Cancellation of performance of the active candidate in the subject in present examination. ( <b>1+0</b> )
6	Tampering with Answer Books of another candidate in the examination hall	Cancellation of performance of the active candidate in the subject in present examination and debarring for two subsequent examinations. ( <b>1+2</b> )
7	Candidate caught during the examination period while copying from the copying work material	Cancellation of performance of the candidate in the subject in present examination plus debarring from one additional examination. ( <b>1+1</b> )
8	Candidate found in possession of copying material but not copied	Cancellation of performance of the candidate in the subject in present examination plus debarring from one additional examination. ( <b>1+1</b> )
9	Candidate found in possession of Mobile.	Cancellation of performance of the candidate in the subject in present examination. ( <b>1+0</b> )
10	Candidate found in possession of Mobile with copying material but not copied	Cancellation of performance of the candidate in the subject in present examination plus debarring from one additional examination. ( <b>1+1</b> )
11	Candidate found in possession of Mobile with copying material and copied.	Cancellation of performance of the candidate in the subject in present examination plus

		debaring from one additional examination. ( <b>1+1</b> )
12	Candidate found exchanging answer books, slip of paper with other candidates	Cancellation of the performance of the candidate in the subject plus debaring from one additional examination. ( <b>1+1</b> )
13	Candidate `X` found in possession of answer book of other candidate `Y` forcibly without his knowledge.	Cancellation of the performance of candidate in that subject in the present examination plus debaring from one additional examination in respect of `X` exonerating `Y`. ( <b>1+1</b> )
14	<b>Impersonation:</b>	
	(i) Candidate who impersonate	Cancellation of the performance of candidate in the subject in the present examination plus debaring from three additional examinations. ( <b>1+3</b> )
	(ii) Candidate for whom impersonate is noticed	Cancellation of the performance of candidate in the subject in the present examination plus debaring from three additional examinations. ( <b>1+3</b> )
14	Candidate found with answer books inserting therein previously written answer books brought from outside	Cancellation of the performance of the candidate in the subject in the present examination plus debaring from the additional examination. ( <b>1+1</b> )
16	Candidate found with answer books of two hand writing one of his own and other different hand writing	Cancellation of the performance of candidate in the subject in the present examination plus debaring from two additional examinations. ( <b>1+2</b> )
17	Cases of mass copying reported during the examination period	Result be held up to punishment. And other actions as deemed fit on scrutiny of detailed report.
18	Cases of mass copying/copying reported by the examiners at Local Assessment Centre (L.A.C) by Individual Examiners	Cancellation of the performance of the candidates in the subject in the present examination. ( <b>1+0</b> )
19	Candidate attaching currency notes to their answer-books with a request to examiners to assess their answer books favorably.	Cancellation of the performance of candidate in the subject in the present examination plus debaring from one additional examination and forfeit the entire amount to Polytechnic's Semester Autonomous Examination Account. ( <b>1+1</b> )

20	Throwing of Question Paper after writing the answer on it to the other candidate	Cancellation of the performance of candidate in the subject in the present examination plus debarring from one additional examination ( <b>1+1</b> )
21	Destroying his own answer-book or his own supplement	Cancellation of the performance of candidate in the subject in the present examination plus debarring from one additional examination. ( <b>1+1</b> )
22	Candidate taking away his own answer book or supplement or removing blank answer books and /or supplement	Cancellation of the performance of candidate in the subject in the present examination plus debarring from two additional examinations. ( <b>1+2</b> )
23	Deliberate free copying between two or more candidates or using any other unfair means at the examination.	Cancellation of the performance of candidates in the subject in the present examination and debarring from one examination of all the candidates involved. ( <b>1+1</b> )
24	Attempts to send out or take out Question paper to outsider	Cancellation of the performance of candidate in the subjects in the present examination plus debarring from result and debarring for five examinations. ( <b>1+5</b> )
25	Bringing or possessing of any weapon in the examination hall and any kind of violence on the part of the candidate against the staff	Cancellation of the performance of candidate in the subjects in the present examination and debarring from five subsequent examinations. To lodge a complaint to the police. ( <b>1+5</b> )
26	Tempering with the Statement of marks or their copies and any other documents issued by the Polytechnic	Cancellation of the performance of candidate in the subjects in the present examination and debarring the candidate for five more examinations and /or to lodge complaint by the concerned Institute/Authority to Police Department. ( <b>1+5</b> )
27	All other cases not covered above shall be dealt independently on the basis of merit/demerits of the cases reported to Sub Committee Examinations	All such cases to be placed before Main Examination Committee and punishment be given as deemed fit.
